We strive for social justice by legally empowering individuals and communities. We believe everyone should be equipped with the knowledge, confidence and skills needed to deal with the law-related issues they are likely to encounter in their lives. Public legal education and information enables people to understand that the problems they encounter in their daily lives may have legal dimensions and empowers them to resolve problems and secure access to justice. Public legal education is a particularly important tool for reaching people in disadvantaged communities.

- We provide education and training on housing, welfare and immigration law to community groups, activists, and volunteers and staff of small NGOs.

Message from Dr Lisa Wintersteiger CEO


Law for Life was established in 2011 in the wake of a global financial crisis and the UK general election. Amanda Finlay CBE has been an integral, founding Trustee and subsequently our Chair, steering Law for Life with wisdom, energy, and commitment. The time has come for our vibrant charity to invite a new Chair that shares our vision for social justice to join us to shape the future of access to justice strategy.

Law for Life has not only weathered extraordinary changes in the access to justice sector but has grown to be seen as a crucial part of the justice infrastructure of England and Wales.

A decade of changes in the policy landscape and in public spending decisions in the UK have left increasing numbers of people without the support that they need to manage the most common life encounters that demand basic legal knowledge and the skills to navigate disputes effectively.For many, this has devastating consequences; deepening existing inequality and disadvantage and foreclosing the opportunities that come with the ability to assert rights and negotiate a better outcome for oneself, family, or community.

Tackling this iniquity and fostering a culture of participation and engagement with the justice system is the work that Law for Life has become expert in; adapting emerging technology; testing creative pedagogical techniques and building a large and trusted network of community groups, front line workers and activists to reach those who otherwise go without help.

We have also worked hard to earn a seat at the policy and research table, sharing our theoretical and empirical understanding of how legal need evolves and impacts certain groups, what can be done to empower people through the law at scale and how systemic issues can be challenged to secure justice and foster democratic engagement.

What's involved?

This role is voluntary and unpaid but reasonable expenses will be reimbursed.

The needs of a small charity can vary considerably, but as a minimum we would like our new Chair to be available to:

- Be able to commit to an initial term of 4 years
- Prepare for and Chair four Trustee meetings and one "away-day" style meeting annually. Meetings are predominantly remote, with occasional in-person meetings in London
- Meet (virtually or in person by mutual agreement) monthly with the CEO to provide appropriate support and keep up to date with the charity's work.
- Represent the charity by mutual agreement with the CEO at key events and at meetings with important stakeholders.
- Be available to respond to and deal with urgent matters necessarily falling within the Chair's remit as and when required.

Chair of Trustees role description and person specification

Law for Life is committed to equality and diversity and welcomes applications from all members of the community, particularly from those currently under-represented including young people, people with disabilities and people from minority ethnic groups.

The Chair is responsible for providing strategic direction for Law for Life. This involves working closely with the Board and our CEO to develop and implement a clear strategic plan that aligns with our mission and objectives. The Chair will also support, advise, challenge, appraise and help develop our CEO.

Strategic Leadership: Responsible for providing strategic direction for Law for Life, working closely with the Board and our CEO to develop and implement a strategic plan. The Chair will also support, advise, challenge, appraise and help develop our CEO.

Governance and Compliance: Ensure that Law for Life operates within the legal and regulatory framework. Overseeing good governance and compliance with relevant UK charity laws and regulations.

Board Management: Take a lead in managing our Trustee board, including recruiting, training and retaining board members, fostering a culture of collaboration, and ensuring effective board meetings and decision-making processes.

Stakeholder Engagement: Build and maintain relationships with key stakeholders, including donors, beneficiaries, government bodies, and the public. The Chair represents Law for Life externally and fosters partnerships to support our mission.

Financial Oversight: Take a lead role in overseeing the charity's financial health, ensuring the charity's financial sustainability, overseeing budgets, and monitoring financial performance. The Chair is supported in this by an honorary Treasurer and a Finance sub-committee of the Board.

Experience and skills

The successful candidate will have the following essential experience and skills

Experience

- Substantial experience working in the justice and/or human rights sectors (including related health or technology fields).
- Proven experience in a leadership or governance role, demonstrating the ability to lead and inspire a diverse group of trustees and stakeholders.
- Strong strategic thinking and vision, with the ability to set and implement the charity's long-term strategic direction and to bring an innovative and creative mindset to the charity.

Knowledge and Skills

- Understanding of governance principles and a commitment to ensuring the highest standards of governance within the charity.
- Excellent communication and interpersonal skills, with the ability to represent the charity effectively to external stakeholders, donors, and the public.
- Proficiency in stakeholder engagement and management, including the ability to build and maintain relationships with diverse groups of stakeholders.
- Strong financial acumen, including the ability to oversee budgets, financial reporting, and financial sustainability.

Personal Qualities

- A genuine commitment to and passion for Law of Life's mission and values, with a demonstrated dedication to social justice and public legal education.
- High ethical standards and integrity, with the ability to lead by example and uphold the charity's reputation.
- A commitment to promoting diversity, equity, and inclusion within the charity and its governance structure.
- A collaborative and inclusive leadership style, fostering teamwork and consensus among board members and stakeholders.
- Resilience in the face of challenges and the ability to make tough decisions when necessary.
- An ability to work in partnership with the Board of Trustees and Chief Executive to ensure that the charity has a clear vision, mission and strategic direction and that the charity, the Trustees and the Chief Executive are focused on achieving these.
